Approved Minutes

Supervisor, Lester Vida, called the meeting to order at 7:00 p.m. and led with The Pledge of Allegiance and a moment of silence and prayer for our service people, veterans and a fellow resident who is hospitalized after a terrible accident. Board members present: David Lawrence, Linda Bailow, Barbara Ferrett and James Korman. There were also seven visitors. A motion was made by Dave Lawrence/Jim Korman to approve the agenda with the addition of library trustee added to new business. M/C.

Community Reports:

Karen Lipovsky, County Commissioner, gave her report of what is going on at the county level.

Nancy House, library delegate, gave her monthly report on library happenings and gave out the usage report.

Barb Ferrett gave her report from the local MTA meeting.

A motion by Jim Korman/Barb Ferrett was made to accept the February 3, 2014 minutes as presented. M/C.

Dave Lawrence presented the treasures' report. A motion by Linda Bailow/Jim Korman was made to accept the report as presented. M/C.

Unfinished business:

A motion made by Linda Bailow/Lester Vida was made to hold the Annual Meeting on March 29, 2014 at 9:00 A.M. at the Greenwood Township Hall. M/C.

Linda Korman, hall cleaning person, has asked for, in writing, a \$20.00 increase for stripping and waxing the township hall floor once a year. A motion by Dave Lawrence /Barb Ferrett was made to increase that portion of the contract from \$200 to \$220. M/C.

Arthur Ferrett, cemetery and township hall grounds keeper, asked for, in writing, a \$15.00 per month increase to cover the cost of lawnmower blades. A motion by Dave Lawrence/Jim Korman to increase the wage from \$500 per month to \$515 per month was made. M/C.

It was noted that business cards have been purchased for the assessor to use when visiting properties.

New Business:

A motion by Dave Lawrence/Jim Korman was made to revise the rubbish assessment to the McClaughty property tax bill from two rubbish assessments to one. M/C.

Discussion on the frozen septic system and repairs that need to be made. The problems will be temporarily fixed for the Board of Review meetings on March 10 & 11 however, further repairs will be needed once the weather has changed and the ground is no longer frozen.

It was discussed that since library delegate, Mike Howard, is hospitalized and will not be able to participate in activities for an unknown length of time that we appoint someone to temporarily replace him. There were no volunteers and the subject will be brought up at our next regular board meeting.

Public Comment:

It was noted that the township web site needs to be updated with the current rubbish assessment cost. Barb Ferrett will take of this. Some further discussion about the web site.

A motion was made by Dave Lawrence /Jim Korman to pay the bills. M/C.
